❖ Council President Schrimpf instructed the one audience member to fill out a green card if they wish to address Council, otherwise citizens' comments are at the end

Minutes:

Council President Schrimpf moved to accept the April 22, 2019 minutes; Councilwoman Howard seconded; passed.

Code Enforcement Report:

- ❖ The April 2019 report was included in the packet.
- ❖ Councilwoman Hughes said that grass clippings are being dumped in the reserves. Mr. Fischer said they can offer best practices interventions like compost piles.
- ❖ Councilman Curl saw a dead animal in a storm sewer. He thinks it could be a racoon or a dog.
- ❖ Councilwoman Howard asked about the open/closed process on the report.

EMS/Fire:

- ❖ There is no report ready today, but Chief Hoechstetter hopes to have it by the second meeting.
- They are in the process of developing a program for the in-charge medics to be certified to install car seats.
- * They are in service more often.
- The fire hydrants need to be painted. They will be getting a quote from one of the former EMTs who does some painting.

❖ April Financials are upcoming.

Planning and Zoning:

- ❖ There is a meeting on Wednesday, May 18, 2019.
- They are working on putting together a list of priorities.
- ❖ The landscape architect will bring her presentation of best recommendations at the next meeting.
- ❖ Mr. Fischer needs a permit for the legal requirements for the basketball court.

Village Planning:

- ❖ The MI phases are moving along. Mr. Fischer is getting about 7 permits per week.
- ❖ Mr. Fischer inspects the setbacks.
- ❖ Council President Schrimpf asked about the house being built on Minerva Lake Road. She wanted to know who was supervising the contractors. She said it seems close to the street. Mr. Fischer said that he has met all the setbacks.

MPCA:

❖ MPCA needs to figure out what to do with the path and the shed. They are still undecided about the shed. Mayor Eisentrout emailed the MPCA president for clarification.

Charter Commission Report:

- * They have been discussing the way they do readings and how to waive readings.
- President Schrimpf said they have slides on their website about what they recommend for waiving readings.
- Councilwoman Howard wondered how they were doing with they are budget.

Mayor's Report:

- ❖ Mayor and legal counsel will be meeting with the City of Columbus about the lakes.
- ❖ Councilwoman Howard received a proposal for the Ponderosa entrance marker. Mayor Eisentrout is waiting for more information from two more masons.
- ❖ Councilman Curl asked about a sign for the pool. There is a pool sign already on Minerva Lake Rd.
- ❖ Councilwoman Hughes wanted to know if anyone else was able to go to the meeting. Mayor Eisentrout said that she wants to start a dialogue with Columbus. Councilwoman Hughes does not want the ball to be dropped. Councilman Benedetti wants to be involved because he said thinks the Village's storm sewer issues are stemmed from Columbus' storm sewer issues. Council President Schrimpf said that one meeting can lead to another. Mayor Eisentrout wants the meeting to be a productive meeting and she fears it going into different directions without it being the professional meeting she wants it to be.

WHEREAS, the Village Engineer has recommended the Village begin a program to inspect and document the current condition of the Village's storm sewer system; and,

WHEREAS, the Village has received a quote for the inspection, cleaning, and recording of Wildwood Road, Elmhurst Road, Westbridge Road, Park Lane, and Park Lane Court from Flowline, LLC, to be started on or about May 7, 2019.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MINERVA PARK, OHIO, THAT:

- **Section 1.** The Mayor and Fiscal Officer of the Village of Minerva Park are hereby authorized and directed to enter into an agreement for the inspection, cleaning, and recording of storm sewers with Flowline, LLC.
- Section 2. The cost of the project shall not exceed \$15,000 without further approval of Council.
- **Section 3.** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

- **Section 1.** The Council hereby awards the 2019 Minerva Park Sanitary Sewer Improvements Project to Insight Pipe Contracting, LLC and authorizes the Mayor and Fiscal Officer to enter into contract on behalf of the Village for the purpose of completing the above-mentioned project pursuant to the contract documents.
- **Section 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

ORDINANCE 08-2019

AN ORDINANCE TO REVISE SECTION 618.19 AND CREATE SECTION 1290.01 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF MINERVA PARK, OHIO

WHEREAS, it is necessary and appropriate to revisit, clarify, and update regulations from time to time; and

NOW, THEREFORE, be it resolved by the Council of the Village of Minerva Park, Franklin County, State of Ohio, that:

- Section 1. Village of Minerva Park Code Section 618.19 is hereby amended to read as follows: "Section 618.19 Maximum Number of Dogs, Cats or Chickens, Ducks, and/or Rabbits Permitted."
 - (a) No person shall keep more than five (5) dogs, cats, excluding puppies and/or kittens less than six (6) months old, in any single-family dwelling, or in any separate dwelling unit in a two-family or multifamily structure within the Village. "Dwelling" and "dwelling unit" as used in this section, include the lot or parcel of land on which the house of building containing the dwelling unit is located, and all other structures located on the lot or parcel.
 - (b) No person shall keep more than five (5) chickens, ducks or rabbits, excluding chicks/peeps, ducklings, and/or kits less than six (6) months old, at any single-family dwelling. Chicken, Rabbits and/or Ducks are not permitted to be kept at any separate dwelling unit in a two-family or multifamily structure within the Village. "Dwelling" and "dwelling unit" as used in this section, include the lot or parcel of land on which the house of building containing the dwelling unit is located, and all other structures located on the lot or parcel.
- **Section 2**. Village of Minerva Park code section be created, Section 1290.01, which shall read as follows:

"Section 1290.01 Chickens, Ducks, and Rabbits

- (a) No Person shall own, keep or harbor any chickens, ducks, or rabbits without meeting the requirements set forth in the following subsection:
 - (1) That a one time permit be required and issued by the Village of Minerva Park prior to acquiring chickens, ducks, or rabbits, and an inspection occur by the Village of Minerva Park within 60 days of acquiring chickens, ducks, or rabbits.
 - (2) That the chickens, ducks, and/or rabbits be kept in a secure enclosure shielded from the street to which it fronts.
 - (3) That an appropriate enclosure (such as a chicken coop for chickens) be provided, and be kept clean and in good repair.
- (b) No person in paragraph (a) shall sell eggs produced by said chickens and/or
- (c) No person in paragraph (a) shall own, keep or harbor a rooster.
- (d) No person in Paragraph (a) shall fail to comply with all other sections of 618, Animals, involving the care and responsibility of animals.

(Continued)

(e) Whoever violates this Section is guilty of a minor misdemeanor for a first offense; whoever violates this Section for a second or subsequent offense is guilty of a misdemeanor in the fourth degree. In addition, for second or subsequent violations, the Court may order the offender to forfeit the animals.

- Section 3. - **Section 4.** All prior legislation, or any parts thereof, which is/are inconsistent with this Ordinance is/are hereby repealed as to the inconsistent parts thereof.
- **Section 5.** This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
