

A RESOLUTION AUTHORIZING THE MAYOR, CLERK-TREASURER, AND MINERVA  
PARK POLICE CHIEF TO ENTER INTO AN AGREEMENT WITH THE FRANKLIN COUNTY  
SHERIFF'S OFFICE TO SUPPORT THE FRANKLIN COUNTY SHERIFF'S OFFICE IN ITS  
OVI TASK FORCE GOALS FROM OCTOBER 1, 2007 TO SEPTEMBER 30, 2008 BY  
ALLOWING THE MINERVA PARK POLICE OFFICERS TO PARTICIPATE IN DUI CHECK  
POINTS FOR OVI TASK FORCE, AND DECLARING AN EMERGENCY

WHEREAS, the Council of the Village of Minerva Park deems it desirous for the Minerva Park Police Department to participate in the OVI (Operating a Vehicle while Impaired) Task Force Goals grant for the safety of Village residents outside Minerva Park boundaries; and

WHEREAS, this task force helps to lower the number of drug and alcohol related traffic crashes; and

WHEREAS, the Franklin County Sheriff's Office has received an OVI Task Force grant from the Ohio Department of Public Safety to reimburse the Village of Minerva Park for all time spent on the task force by Minerva Park Police Officers;

NOW THEREFORE, be it resolved by the Council of the Village of Minerva Park, Franklin County, State of Ohio, that:

- Section 1. The Mayor and the Clerk-Treasurer and Police Chief of the Village of Minerva Park are hereby authorized to enter into agreement with the Franklin County Sheriff's Office for support by the Minerva Park Police Department in the OVI Task Force goals set forth in the attached contract.
- Section 2. The hourly rate for such special duty for the Minerva Park Police Officer's shall be set at \$34.50 per hour and is totally reimbursable by the grant obtained by the Franklin County Sheriff's Office as stated in the attached contract.
- Section 3. All prior resolution(s) or any part thereof, which is(are) inconsistent with this resolution is(are) hereby repealed as to the inconsistent part(s) thereof and the remainder of said resolution(s) not inconsistent with this resolution shall remain in full force and effect.
- Section 4. Council declares this to be an emergency measure necessary for the preservation of the public health, safety, and welfare of the residents of the Village of Minerva Park, such emergency arising out of the need to submit the signed agreement to Franklin County Sheriff's Office. Wherefore, this resolution shall take effect and be in full force from and after its passage.
