

## RESOLUTION 2013-08

### A RESOLUTION SETTING THE FEES FOR MEMBERSHIPS AND DAY PASSES FOR THE MINERVA PARK POOL FOR THE 2013 SUMMER SEASON AND DECLARING AN EMERGENCY

WHEREAS, the Village of Minerva Park operates the Minerva Park Pool, and

WHEREAS, rates for memberships and day passes must be set for the 2013 Summer Season

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MINERVA  
PARK, FRANKLIN COUNTY, STATE OF OHIO, THAT:

Section 1. The 2013 fees for Minerva Park Pool memberships and day passes are set in Exhibit A and are made a part hereof as if it were fully written herein.

Section 2. The Village Mayor and Fiscal Officer in consultation with the Pool Manger are authorized to set rates for special events, classes, and other pool related activities not covered by Exhibit A.

Section 3. The Village Mayor, Fiscal Officer, and Solicitor are authorized to take further actions consistent with this resolution that are needed to carry out the intentions of this resolution which is setting rates so that advertising can be started as soon as possible.

Section 4. All prior ordinance(s) or resolution(s) or any part thereof, which is (are) inconsistent with this resolution is(are) hereby repealed as to the inconsistent part or parts thereof and the remainder of said ordinance(s) or resolution(s) not inconsistent with this resolution shall remain in full force and effect.



Section 5. Council declares this to be an emergency measure immediately necessary for the public peace, health, safety and welfare of the residents of the Village of Minerva Park. Such emergency arising out of the necessity to design and print the flyers and begin advertising the new pool rates well before the date at which advance sales of memberships begin in order to increase sales.

Section 6. This Resolution shall be in full force and effect at the earliest time allowed by law after the passage of said Resolution and with the Mayor's signature.
