

## **ORDINANCE 01-2016**

### **AN ORDINANCE ACCEPTING THE ANNEXATION OF A 99.2 +/- ACRES, MORE OR LESS, TO THE VILLAGE OF MINERVA PARK**

**WHEREAS**, a Petition having been filed for annexation of a 99.2 +/- acre tract, more or less to the Village of Minerva Park with the Board of Franklin County Commissioners, by Aaron L. Underhill, Attorney at Law on behalf of Marilyn A. Groezinger, Frank H. Groezinger, Jr., Frank H. Groezinger, Jr. Trustee and Minerva Lake Corporation; and

**WHEREAS**, proceedings having been had before the Board of Commissioners of Franklin County on October 20, 2015, wherein said Commissioners approved the annexation; and

**WHEREAS**, more than sixty days having elapsed from the date of filing of the transcript of such approval by the Board of Franklin County Commissioners with the Village Fiscal Officer;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MINERVA PARK, FRANKLIN COUNTY, STATE OF OHIO, THAT:**


**Section 1.** That the proposed annexation, as applied for the in the petition by Aaron Underhill, Attorney at Law on behalf of Marilyn A. Groezinger, Frank H. Groezinger, Jr., Frank H. Groezinger, Jr. Trustee and Minerva Lake Corporation, which petition was filed with the Board of County Commissioners of Franklin County, Ohio, on September 11, 2015, and which petition prayed for the annexation to the Village of Minerva Park of certain territory adjacent thereto and herein after described, which petition was approved for annexation to the Village of Minerva Park by the Board of Franklin County Commissioners on October 20, 2015, be, and hereby is, accepted. The territory annexed hereby is described in the legal description attached hereto as Exhibit "A" and made a part hereof as if fully rewritten herein. The certified transcript of the proceedings for annexation with an accurate map of the territory, together with the petition for annexation and other papers relating to the proceedings thereto of the County Commissioners are all on file with the Fiscal Officer of the Village of Minerva Park and have been for more than 60 days.

**Section 2.** That the Fiscal Officer be, and hereby is, authorized and directed to make three copies of this Ordinance, to each of which shall be attached a copy of the transcript of proceedings of the Board of County Commissioners relating thereto and a certificate as to the correctness thereof. The Fiscal Officer shall then forthwith deliver one copy to the County Auditor, one copy to the County Recorder, and one copy to the Secretary of State, and shall file notice of this annexation with the Board of Elections within 30 days after it becomes effective.

**Section 3.** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in open meeting of this Council and that any and all deliberations of this Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.


