MAYOR'S REPORT

Only a few residents were present to ask about the golf course issue during a question & answer period held before the regular April Council meeting. Here is an update ... In this past month, we have interviewed and are in the process of hiring a planner/consultant, and we met with our annexation attorney to draft a Community Benefits Package and address zoning items of concern to submit to Dominion Homes. The negotiating process is ongoing, and we will attempt to keep you informed of any progress to the best of our abilities. I will have Saturday office hours May 29 from 11:00a to 2:00p, if you would like to stop in.

We had a special guest speaker from the Ohio Consumer Counsel (OCC) to discuss aggregation and the required procedures for initiating gas aggregation. We will explore the 2 plans — opt in and opt out.

The following reports were made at the Council meeting:

Police: Chief Hillard noted that the Concealed Gun Carry Law has gone into effect, and we have posted the necessary signs. He, Sgt. Silverman, Clerk/Treasurer Suzanne Coulter, and I are currently seeking grant funding through the Ohio Office of Criminal Justice Services for Mobile Data Terminals. The deadline is mid-May.

Special thanks go to our police Chief Hillard, who has picked up several extra weekend shifts left uncovered by an injured officer, adding these extra duties to an already busy schedule of court appearances and loads of administrative work.

EMS: The EMS is continuing

its grant-seeking efforts and working to complete their inventory.

Engineering: Stu Wilms reported that the **storm sewer clean-outs** should be completed by the time this goes to print. The manhole cover on Minerva Lake Road wasn't repaired properly, and we're still working on it.

Legal: Narcos Tsiliacos commended the Council and the Mayor for the long hours, hard work, and the ongoing meetings concerning the golf course issue.

Planning and Zoning: Their subcommittee is still working on the **fee schedule**. Zoning issues addressed at the last zoning meeting included ...

- Bread of Life Church requested permission to gravel an existing lane (driveway) and for a curb cut – approved.
- Three fence permits were requested – two were granted and a third would need a variance from Council. This was later granted at the regular Council meeting.
- P&Z Chair Pat Mangan submitted a second draft of the letter to be sent to the multifamily residence on Lakewood Drive. A few more changes need to be made to address code violations.

Swim Club: Board Advisor Tom Shannon reported that the pre-season ticket sale was successful. These monies will go toward the cost of opening the pool and some repairs.

Here were the Committee Reports:

Community: Councilwoman Sharon Bierman is coordinating the lake cleanup effort and addressed some of the areas throughout the Village that need to be spruced up.



Finance: Councilman Don Champney briefly addressed the bills to be paid (the "warrants") and approval was given to pay them.

Legislation: Ordinance 01-2004 - Quarterly surcharge for loan repayment of waterline – third reading accepted, passage approved.

Safety: There was a **one-car fatal accident** at Cleveland Avenue and Woodley (not one of our residents) and the question of jurisdiction was raised. This is being addressed.

Service: Nothing to report at this time.

Streets: Councilman Ron Yarano reported that **pothole repairs** should begin mid-April. We are waiting until the asphalt plants open so we can get the best prices for asphalt. The Village is inventorying **traffic control signs**, replacing only those that are virtually unreadable.




