## CPR & First Aid Courses

Newly revised for 2006, American Red Cross Workplace CPR and First Aid courses will be offered in two sessions, starting at 6:00p and ending no later than 10:00p at the Minerva Park Community Center.

Session 1

February 28 (CPR) & March 7 (First Aid)

Session 2

April 10 (CPR) & April 12 (First Aid)

All previously certified individuals will need to retake both courses to recertify. Certification lasts one year for CPR and three years for First Aid.

Sign up for one or both classes within a session. Cost for both CPR and First Aid in a session is \$35, and for a single course \$25. Costs cover insurance, participant material/rental costs, and Red Cross fees. Participants should be able to kneel/sit on the floor, complete all skills, and pass written tests to obtain certification. Participants should be Minerva Park residents, members of Columbus Outdoor Pursuits, or Girl Scouts.

### MERRY CHRISTMAS COPS FOR KIDS

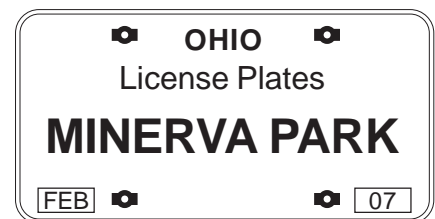

# MAYOR'S REPORT

I hope everyone had a Merry Christmas, and I thank you on behalf of your Village staff for the holiday greetings and goodies. They were very much appreciated.

Your Village officials and employees are winding up the year, and all departments are currently working on their 2006 in Review reports, which should be in the February issue of the Villager.

**Code Enforcement:** We continue to work with City of Columbus and the Northland Community Council addressing the Cleveland Avenue and Route 161 areas as well as our own vendors within the Village limits and some residential properties.

The Wildwood Road street sign at Wildwood and Cleveland Avenue blew off during the last wind storm. Westbridge Road resident Nan Yusko was kind enough to take the sign and all the hardware home and call me. Because the City of Columbus is responsible for replacing these signs, they were notified, promptly picked up the sign, and placed a work order to have it reinstalled. I apologize for any problems this has caused residents on Wildwood, and we are expediting this as quickly as possible.

All Council members except Chuck Gibson, who was excused, were present for the regular

Council meeting on December 11. The following departmental reports were made:

**Police:** Chief Bobbie Hillard reviewed his monthly report. The police department had been nominated and received an award from Mothers Against Drunk Driving for their efforts to deter drunk

driving. Chief Hillard represented the department and the Village at a luncheon at the Columbus Country Club December 19 to accept the award (story on page 1).

**EMS:** Chief Rick Hoehstetter reviewed his monthly report and thanked the Safety Committee members, particularly Chair Chuck Gibson, for their support these past months.

**Engineering:** Mike Flickinger added his comments under the Service and Street Committee reports.

**Legal:** Law Director Kerry Boyle had nothing to report.

## Planning and Zoning:

**Code Enforcement**  
Officer Dick Busick reported that the owner of the strip mall at Woodley and Cleveland Avenue was sent a violation letter requesting him to maintain his property-remove trash, mend the fence, address parking violations, and drainage issues. The gas station at Woodley has again been cited into Mayor's Court and has a case pending in Environmental Court. A Cleveland Avenue business has a sign violation, and another Cleveland Avenue business has received a stop work order for renovating a garage into office space without a permit.

## Minerva Park Community

**Association:** The Children's Christmas Party was held Saturday, December 16, and the Fifth Annual Carriage Ride event was held Sunday, December 17. The Association is selling note cards of Ray Beougher's art work depicting six different scenes of Minerva Park. ## Northland Community

**Council:** There was no report at this time.

The following committee reports were made:

**Community:** Councilman Todd Walter had nothing further to add to the Community Association report.

**Finance:** Councilman Don Champney asked for the Council to approve two purchase orders – \$11,600.00 to Whalen & Co. for the audit and \$4,000 to Wiles, Boyle, Burkholder, et al., for legal services – both approved. He asked

and received the Council's approval for warrants totaling \$112,010.86. A Finance Committee meeting will be held Tuesday, January 9, at 7 p.m.

**Legislative:** Councilwoman Pam Park-Curry asked the Council to consider the following legislation:

**Resolution 2006-24** - Adopting a plan under the Ohio Public Employees Deferred Compensation Program or participation by eligible employees of the Village. Rules suspended, third reading waived, passed as an emergency.

**Resolution 2006-25** - Authorizing the Clerk-Treasurer to transfer funds from the General Fund to the EMS Vehicle Fund and to declare an emergency. Rules suspended, second and third readings waived, passed as an emergency.

**Resolution 2006-26** - Adopting the Rules of Council for 2007 and to declare an emergency. Third reading accepted, passed as an emergency.

**Resolution 2006-27** - Authorizing the Mayor and the Clerk-Treasurer to enter into contract for health insurance for Village employees for 2007 and to declare an emergency. Rules suspended, second and third readings waived, passed as an emergency.

**Resolution 2006-28** - Amending appropriations for the General Fund of the Village during the fiscal year ending December 31, 2006 and to declare an emergency. Rules

suspended, three readings waived, passed as an emergency.

**Resolution 2006-29** - Authorizing the Clerk-Treasurer to transfer funds from the General Fund, Street Maintenance, into the Waterline Debt Services Funds, and to declare an emergency. Rules suspended, three readings waived, passed as an emergency.

**Resolution 2006-30** - Establishing the appropriations for all funds for the first three months of 2007 for the Village during the fiscal year ending December 31, 2007, as an emergency. Tax budget attached. Rules suspended, three readings waived, passed as an emergency.

**Safety:** In Councilman Gibson's absence, Safety Committee member Councilwoman Bierman reported on the Safety Committee meeting held December 2. Chief Hillard would like to continue the roll-over program of purchasing cruisers, consider merit raises and salary reviews, and updating equipment. Chief Hoechstetter's main concern was upgrading to the LifePak 12 to meet the requirements set by City of Columbus, phones and radio purchases, and stipends for his volunteers. These will all be discussed in depth at the upcoming Finance Committee meeting on January 9.

**Service:** Councilwoman Sharon Bierman reported on the Service Committee meeting held December

4. The Dam Restoration Project (ODNR-mandated tree removal orders, and the need for a dam safety study to have an Operations Maintenance and Inspection Manual in place as well as an Emergency Action Plan) was discussed, along with upcoming repairs for the leaf machine. She has completed the annual MS4 report, itemizing the efforts this past year to keep our storm sewer lines in good repair.

**Streets:** Councilman Jeff Rigg has been addressing the punch list items from the last street project – clean-up at the Wildwood Road & Cleveland Avenue intersection and valve covers on Woodley.

I would like to take this opportunity on behalf of my fellow elected officials and Village staff to wish everyone a happy, safe, and healthy New Year. I look forward to another year of service to Minerva Park and to working with all of you to accomplish good things for our Village. •
