

MAYOR'S REPORT

I hope everyone had a wonderful Christmas and Santa was good to you all. Many, many thanks for the thoughtful cards and wishes and the delicious treats.

Emerald Ash Borer: The infestation that is plaguing our state and neighboring states (Michigan, Illinois, Indiana, and Kentucky, to name just a few) has been in the news quite a bit lately. What is an Emerald Ash Borer (EAB)? It is a metallic green beetle that measures about 1/2" long and leaves a "D"-shaped exit hole in the bark when it emerges from the tree in the spring. While the adult feeds on ash foliage and causes little damage, it is the larvae that can ultimately cause the death of a tree. It feeds on the inner bark of ash trees, thereby disrupting the tree's ability to transport water and other nutrients. When Green Team Committee Chairman Greg Wittmann attended a recent seminar on the EAB, he found that there was grant funding available through the Ohio Department of Natural Resources (ODNR) to either treat or remove affected ash trees on public lands. Greg and Green Team Committee members Karen Cogley, Bob Gale, Jennifer Pauken, and I invested a great deal of time drafting the mandatory Management Plan and

completing the grant application to meet the December 15 submission deadline. The Green Team is an exceptional group!

Like most ODNR grants, this is a 50%-50% matching, reimbursement grant. We have applied for \$5,000 from ODNR and will match the \$5,000, if our grant application is approved, for a total of \$10,000 to eradicate EAB on Village land. Thank you to the Village Council (particularly Legislative Chair Sharon Bierman and Clerk-Treasurer Suzanne Coulter) for supporting the Green Team, quickly and thoughtfully processing this application. We should hear from ODNR's State Urban Forestry Coordinator by March 2011. For more information about the Emerald Ash Borer, see page 8.

MORPC Meeting: I had a very

interesting and productive meeting on December 6 with several representatives from the Mid-Ohio Regional Planning Commission (MORPC): one of the leads for the 2010 Census, an Associate Planner, and one of our contacts for our street repair projects associated with Ohio Public Works Commission's (OPWC) Small Government Division. We touched on many topics ... funding through the Clean Ohio Assistance Fund for rehabilitating the ravine and creek beds, funding and advisors through the Franklin County Soil and Water Agency, land use, watershed, and balance growth planning, to mention a few. At this point, we will have to wait and see what our new Governor plans to do with the 2011 budget (specifically, budget cuts) and what

funding will remain available. More on this later.

We will have more next year! As usual, the volunteers and bakers outdid themselves and are too numerous for me to thank individually. I certainly would not have been able to do this without all of you. Boy Scout Troop #007 assisted us for the ninth year in a row. They included Trey & Tyler Williams, Thomas & Jay Shimko, Alex Faytle, James Lake, Jacob Austrino, Nathan LaChappelle, Ryan Milligan, Scoutmaster Sam Austrino, Adult Leader Tony LaChapelle, and Assistant Scoutmasters Dick Busick and Jim Lake. Three of the scouts in this troop have now attained the rank of Eagle Scout. Congratulations!

Clerk of Courts: Sadly, we said good-bye to Clerk of Courts Christi Nordman because she accepted a full-time position with the Westerville schools. Office assistant Christy Williamson was promoted to Clerk of Courts. My Assistant and Zoning Clerk Sara Schumacher will take on the added duty of Deputy Clerk of Courts. Sharing these jobs is estimated to save the Village about \$13,000. See Ordinance 6-10 and Resolutions 10-37 & 10-42 under Legislation.

Please be vigilant. As has

happened in past years, we seem to have an individual or individuals attempting to steal from cars parked on the streets or in driveways. The goal seems to be taking loose change. Please lock your car doors at all times and set alarms if you have them. See the Safety Tip from our Police Department on page 8.

All Council Members were in attendance at the regular council meeting on December 13. The following reports were made:

Police: Acting Chief Adam Beach was excused, and congratulations were extended to his wife Michelle and him on the birth of new daughter Addyson. His monthly report was reviewed.

EMS/Fire: Chief Rick Hoechstetter reviewed his monthly report. Two hydrants will need repair in the spring.

Legal: Jennifer Croghan confirmed that the agenda should be amended to have the ordinances voted on before the resolutions.

Planning & Zoning and Code Enforcement: Dick Busick reported that there was no Planning & Zoning meeting in December (no pending applications) and that Good Dog Grooming has moved from the Woodley shopping center to the site of the former veterinary hospital south on Cleveland Avenue. He also reviewed his monthly report.

Passed as an Emergency

When you attend a council meeting or read the Mayor's Report, you will note that some legislation is passed "declaring an emergency." It sounds sudden and unexpected, but what does it really mean? According to the Ohio Revised Code, to pass a piece of legislation as an emergency simply means that the legislation will take effect immediately after passage instead of 30 days later.

There are numerous reasons why a piece of legislation must take effect immediately, including to meet an important deadline, to sign a contract to keep services maintained, to start a project, or to take action on a hiring or benefits decision that needs to start as soon as possible. No matter what the

reason, Council must consider it to be in the best interests of the health and welfare of the residents of the Village to have the legislation take effect immediately.

Despite it sounding sudden and unexpected, most pieces of legislation passed as an emergency are neither sudden nor unexpected. Much legislation is done on an annual basis such as contracts for services, the budget, and rules of council for the ensuing year. Street projects that are passed "declaring an emergency" often go through years of discussion and planning. These and other pieces of legislation are discussed in committee meetings and work sessions, and many times they are read at Council month after month before being passed.

When they are passed, if they need to go into effect immediately, they are passed declaring an emergency. So the next time you see "declaring an emergency," read it as "will take effect immediately."

Council: MPCA Vice President Dave Way, NCC Representative Bob Gale, and Mayor Eisentrout attended the NCC Annual Holiday Dinner at the Hunan House on December 7.

The following committee reports were made:

Community: Councilman Matthew Danzuso reported on Kid's Safety Day to be held May 14, a planning meeting to discuss the future site of the Minerva Park Veterans Memorial would be held on December 20, and Lake Clean-up would be held on April 30.

Finance: Council President Pam Park-Curry received approval for the November 2010 financials, including expenses totaling \$120,940.52. She also received approval for Then & Now POs for engineering costs for Rounds 23 (\$3,542.45) & 24 (\$4,181.40) Street Projects, \$23,480 for the PNC Bank Lake Bond payment, and \$5,701.01 for new bulletproof vests for the Police Department.

Legislation: Councilwoman Sharon Bierman asked the Council

to consider the following legislation:

Ordinance 4-2010 - Adopting

Resolution 2010-40 - Setting a pay range for MP Police Chief. First reading, waived 2nd & 3rd reading, passed as an emergency.

Resolution 2010-41 - Submitting a grant mitigating the effects of the Emerald Ash Borer and establishing a management plan. Three readings waived, passed as an emergency.

Resolution 2010-42 - Establishing a pay range for Deputy Clerk of Courts. Three readings waived, passed as an emergency.

Resolution 2010-43 - Authorizing a user agreement with Columbus for dispatch radios. Three readings waived, passed as an emergency.

Safety: Councilman Todd Walter reported that there were two Oral Boards of Review potential candidates for the Police Department. The Village received about 40 applications for the Chief of Police position. The Safety Committee, consultant Jeff Miller, and the Mayor have narrowed the field to three candidates.

Service: Councilman Roberto

Section 432.44, Traffic Code, a ban on texting while driving in Minerva Park. Third reading accepted, passed.

Ordinance 6-2010 - Establishing the position of Deputy Clerk of Courts. Three readings waived, passed as an emergency.

Resolution 2010-28 - Authorizing the Mayor and the Clerk-Treasurer to enter into contract for health insurance for full-time police officers and the Mayor for 2011. Third reading accepted, passed as an emergency.

Resolution 2010-36 - Updating the faithful performance bond required for the Clerk-Treasurer. Third reading accepted, passed as an emergency.

Resolution 2010-37 - Updating the faithful performance bond required for the Clerk of Courts. Third reading accepted, passed as an emergency.

The Minerva Park Police Department would like to extend a Happy New Year to everyone, and wish all a very safe and happy 2011!

In the December Villager, we mentioned that most thieves are "opportunists." That basically means that, if thieves see an easy target, they will make that attempt to steal items from you. You can prevent this or drastically drop the odds of being a victim by following these simple tips:

- Park your vehicle inside of your garage at night and be sure to close your garage after dark.
- If you cannot park your vehicle inside of a closed garage, remove all loose change, CDs, GPS devices, or other valuables from your vehicle (including the automatic garage door remote).
- If you must park your vehicle in the street, park it under a street light or near a location where it easily can be seen from your home.
- Never leave your vehicle unattended while the engine is running! If you have a remote starting device that will shut the engine off without the key in the ignition if it's put into gear, please keep in mind that criminals also have been known to possess manufacturer keys that can allow them to still steal your vehicle!

Some people leave their cars unlocked and nothing inside for a thief to steal, with the thought that "if the door is unlocked, the thief won't break my window to get in." There are issues with that line of

thinking. First, by leaving the door unlocked, you are giving the thief an open invitation to steal your vehicle by either breaking the ignition or by using a stolen manufacturer key. Second, you are making it easy for them to hide as police officers drive by on patrol. If a police officer sees someone in a driveway walking around a car looking inside of it, that raises more attention than a person already sitting in a car.

Officers working late-night hours also see many homes with their garage doors left open. We try to contact the homeowners when we can, but sometimes it's difficult to awaken people, so please remember to check your garage doors when you settle in for the night. This prevents a thief from stealing something from your garage and often prevents them from gaining entry into your home through the garage.

Minerva Park doesn't have very much street lighting, and the Village can get dark at night. It makes seeing people who creep around very difficult, so you can help by installing more lighting around your home, driveway, and garage areas. But most of all, please never hesitate to call 9-1-1 if you see someone who just shouldn't be there or someone who is acting suspicious. Trust yourself and never be afraid to call, because you are your police department's "eyes and ears"!
