A Pair of Rare Ducks

In mid-December, my grandpa Paul Miller (East Shore Court) saw a pair of ducks that appeared to him to be unlike your average Mallard. He spotted the ducks in the North Lake, right in his back yard. When he saw the, immediately he got out his bird book and searched to see if any of the birds looked close to the ones in his back yard. When he got to page 82, he knew right then that it was the Tufted Duck. He could tell in the book that it was definitely the Tufted Duck because it obviously had a tuft, and it was the same colors. The book also showed the males and females. Over a 2-week period, my grandpa saw them swimming almost everyday out in the lake.

One afternoon I received a call from my grandpa saying that he had seen them again. He wanted me to see them so badly! The next day, I went over to his house for dinner. My grandpa was so eager for them to show up. While everyone was sitting the table, I was on the couch looking out at the lake, when all of a sudden I saw a pair of chicken-looking creatures sitting on a log out in the water! I knew they had to be the ones that my grandpa was telling me about, so I called him over, and he said, "Nope, those aren't it. They were much different." I asked him to get out the bird book and turn to the page that the Tufted Duck was on. Indeed, I



was right! The ones that I spotted were the female Tufted Duck. I just knew I was right!

The Tufted Duck is found in Europe and Asia - not the U.S. That is what makes them extremely rare here. It is smaller than a Mallard, and a male is black with a white circle on its back. The female is a brownish color with different shades of brown, yellow, orange, and tan. They both have bright orange webbed feet. The male has a black tuft, and the female doesn't have a tuft at all. One of the most interesting facts about the Tufted Duck is that it swims under water! It will dive under and come up in another spot! It was really cool to see it happen!

Still, we did not know what the unusual bird was for sure, so we decided to ask some people about it. Marcia Howden is a birdwatcher, and we told her everything we saw and all that we knew about the bird. She said, "It has to be a Merganser of some sort. If it were truly a Tufted Duck, you

would have birdwatchers from other states coming just to get a look at it." After what Marcia said, we decided to look up the Merganser. The moment we saw the images of the Merganser, we knew it wasn't it! It didn't have any of the characteristics of the Tufted Duck. After we talked to Marcia, we went to Birds Unlimited in Westerville and spoke with one of their managers, who said, "It sounds like the Tufted Duck, but that would be very rare in Ohio. There have been many birds from Europe and Asia sighted in Ohio this year, but I haven't heard of any Tufted Ducks being seen." Several people said it would likely be a Grebe because of the swimming underwater, but the color and size description did not match. Still this mystery continues.

My grandpa and I can't say for sure that this unusual duck is indeed the Tufted Duck. By looking at many pictures and reading much about it, we are convinced that it is. MAYOR'S REPORT

It has been a busy month for meetings. Here are just a few:

Pool: We had our first pool meeting on February 6 to plan the 2012 season. Our Discount Pool Membership Day will be held on April 15 from noon to 3p at the Community Building. Weather permitting, the pool will open Saturday, May 26, at noon. Upcoming events include one or two Wine & Cheese events, a Family Fun Night and perhaps a Resident Appreciation Day or Night (a new concept suggested by our Pool Manager, John Friedel). Dates and times are yet to be confirmed, so watch future issues of the Villager.

Coffee with Council: As I promised last year, an Ohio Department of Natural Resources (ODNR) speaker, Gary Comer, addressed those who attended the January 23 Coffee with Council about controlling the Canadian goose population. Numerous programs and techniques were presented, such as harassment to discourage geese from nesting, habitat modification (planting tall vegetation along the shoreline), passing legislation prohibiting feeding of the geese and posting signs indicating as such, erecting barriers around the lakes such as pond grids, noisemakers, dogs as deterrents, addling (egg shaking),

nest destruction, and a goose round-up. These are all options the Council is considering. We will keep you informed and continue to seek input from the community.

2012 Street Project: Streets Committee Chairman Charles Legg, Village Engineer Mike Flickinger, Fiscal Officer Nancy White, and I met on January 24 to discuss the upcoming street repair project schedule. Please see Councilman Legg's report under the Streets Committee report.

March Council Meeting Speaker Scheduled: Lori Gischel from the Regional Income Tax Agency's (RITA) Worthington office will speak about income tax issues relevant to our Village, i.e., filers and non-filers, steps that can be taken to collect taxes from residents, and commercial vendors who are not paying, revenues collected. She also will cover RITA's customer service, the possibility of privatized and central collection by the state of income tax revenues, and how this may impact municipalities.

Playground: A representative from our liability insurance company arranged for a safety inspection of our playground equipment on February 6. I will share this report with you once I have received it.

All Council members except Roberto Segovia, who was absent due to illness, were present for the Regular Council meeting, held on February 13.

Speaker: Amelia Costanza from the Mid-Ohio Regional Planning Commission (MORPC) made a brief presentation about the 2012 Metropolitan Transportation Plan and talked about MORPC's role as a federally mandated

Metropolitan Planning Organization. The 2012 Plan will address issues such as traffic congestion, air quality, and mobility challenges through long-range planning. MORPC will coordinate planning with local governments to identify these needs and direct state and federal funding. Additionally, the 2012 Plan will be instrumental in setting objectives, mapping strategies, and measuring how goals are to be met. Areas

Law Director: Jennifer Croghan had nothing to report.

Planning & Zoning and Code Enforcement: Code Enforcement Officer Dave Hays was excused. There was no P&Z meeting in February.

Minerva Park Community Association: Councilman Dave Way reported on behalf of MPCA President Lisa Craddock Thitoff. Northland Community Council - the 2012 NCC election of officers took place at the February 7 meeting with the following results: Emmanuel Remy was elected as President; Gerry O'Neil as Vice President; Brandon Boos as Secretary; Sandy LaFollette as Treasurer. The Annual Awards Banquet will be held on March 23 at Villa Milano. The Rapid Bus service on Cleveland Avenue is being studied. Brandon Boos asked for a community profile for each association and for each representative to NCC.

Community: Councilman Dave Way had nothing further to report.

Finance: Council President Pam Park-Curry received approval from the Council for the December financials totaling \$101,041.93 and the 2011 financials totaling \$1,462,049.27. A Finance Committee meeting is scheduled for February 27 at 7:00 p.m.

Legislative: Councilwoman Sharon Bierman asked the Council to consider the following legislation (minervapark.org/legislation/):

Resolution 2012-2 - Accepting the Amounts by th Budget Commission. Waive 3 readings, passed as an emergency.

Resolution 2012-3 - General Liability Insurance for May 2012 - May 2013, 1st reading.

Resolution 2012-4 - Pool Vending Machines contract, 1st reading.

Ordinance 1-2012 - Garage Sales, 1st reading

Safety: Councilman Todd Walter had nothing to report.

Service: There was no report.

Streets: Councilman Charles Legg reported on the 2012 Street Repair Project meeting. A tentative schedule was agreed upon. Engineering will begin on May 1 with advertising for bids during the weeks of June 11 and June 18, and

acceptance of bids on June 29. Council will discuss the bids at the July 7 work session, award the contract at the June 9 Council meeting. A pre-construction meeting with the contractor will be held on July 16. Construction will begin July 23. We hope to finish the project before school begins on August 15. As with past projects, the residents most affected will be kept informed as we progress.
